IN BRIEF

The following dates have been made public to the community with the Shire's Fire Break Notice 2024/25:

Restricted Burning Period:

• 16th October 2024 – 31st October 2024

Prohibited Burning Period:

• 1st November 2024 – 28th February 2025

Restricted Burning Period:

• 28th February 2025 – 29th March 2025

It was discussed that current weather and ground conditions in addition to high fuel load warrant a cautious approach to burning restrictions. The Committee agreed to modify the previously advertised restriction dates to the following:

Restricted Burning Period:

• 16th October 2024 – 17th October 2024

Prohibited Burning Period:

• 18th October 2024 – 28th February 2025

Restricted Burning Period:

• 28th February 2025 – 29th March 2025

Shire to circulate messages regarding Prohibited Burning Period for Easter and Anzac Day.
